# **Executive summary**

The Childcare Sufficiency Assessment (CSA) has been carried out to help ensure there is enough childcare for working parents or for them to take up training opportunities that lead to work. The assessment looks at the childcare market in Leeds, estimating demand using a variety of indicators and assumptions, comparing this to supply. This assessment is an update to the 2021-2022 CSA for elected council members. It may also be of interest to parents, providing them with an overview of the childcare which is offered across the city and in their locality. Existing and potential childcare providers will also find the information provided in the assessment useful when considering a change to their delivery models or expanding their provision or looking to develop in new areas of the city and should be used alongside their own market research to assess demand in particular areas and points in time.

The childcare market is particularly dynamic, with many factors affecting demand and supply, particularly parental choice. Therefore, the findings of this report are indicative only and further detailed analysis of local areas should be undertaken by childcare providers to fully understand the local market.

Following a period of growth where the birth rate peaked at 10,350, births in Leeds have declined significantly over the last few years to just over 8,600 city-wide. The 5 years of falling birth rates between 2016 and 2020, equates to a 21% decline during this period, and the latest NHS data shows a very slight increase on the previous year as shown in 'Figure 1 - Births in Leeds'. It is too early to determine whether this will continue to rise, although the Office for National Statistics (ONS) do forecast a decrease in the 0-4 population in Leeds over the next 5 years. A summary of the birth rates by each Childcare Planning Area since 2011 are shown in Appendix A.

# Main findings of the CSA

- Following several years decline in births, the latest information shows these have stabilised at just over 8,600.
- Although providers are continuing to respond to supporting two-year-old places, the percentage take-up of FEEE entitlement by eligible two-year-olds varies across different areas of the city and further work is ongoing to increase the overall take-up of the offer.
- Providers are raising concerns about the ongoing challenges with staff recruitment and retention. This has made the sector vulnerable.
- Significant rising costs in utilities and inflation is affecting financial viability.
- Providers are working with increasing numbers of children with additional needs and requiring support, highlighting speech, language and communication delay.
- Providers are concerned at underfunding and the amount received from the local authority does not cover the cost of providing free early education places.
- There are significantly fewer active child minders across the city compared with previous years, and a decline in the number of new child minders becoming registered. However, as the city-wide average of Free Early Education Entitlement (FEEE) increases Summer 2021 89%, Summer 2022 93% this is not anticipated to affect the availability of places.
- The lower number of children being born is starting to impact on many childcare providers across the city, who are experiencing lower numbers on roll and this is therefore negatively impacting on their business.



# **1. Introduction**

## **1.1 Leeds' priorities**

The 'Best City Ambition' is the overall vision for the future of Leeds, in which the aims of 'improving lives of families who are most likely to experience poverty' and 'ensuring that all children in all areas of the city have the best start in life and enjoy a healthy, happy and friendly childhood' are set out. By supporting the commitment to starting well, we close educational attainment gaps between the most and least advantaged children. One of the ways in which we can do this is to support families and children to attend early years education settings and increase the take up of free early education entitlement for children, particularly in areas of deprivation or where take-up is low. These commitments are underpinned by the Leeds 3A's Strategy and Children and Young People's Plan and form a key focus of the work of the Sufficiency and Participation Team and its priorities.

## **1.2 Role of the Sufficiency and Participation team**

The Sufficiency and Participation team, based within Children and Families directorate at Leeds City Council, is responsible for meeting statutory duties with regards to ensuring that there are sufficient high quality local learning places for all children and young people living in Leeds between the ages of 0 and 19 (25 for young people with additional needs). Through analysing and interpreting local demographic, housing and other data sources and working with learning and childcare providers and other stakeholders, the team plans how to provide appropriate numbers of learning places to meet future need.

The data used to assess and plan Early Years provision is organised by areas, with the city divided into 42 geographical areas called Childcare Planning Areas (CPAs). These areas are used in planning Early Years and primary provision and the data contained within Appendices B to D of this report is presented by CPA. The areas have been determined by considering natural boundaries and other local features such as major roads, rivers and areas of population. Although provision is often planned at a CPA level, the demographics and housing in neighbouring areas is considered along with patterns of where children access provision relative to where they live. Sometimes, for the purposes of planning provision, a particular part of a planning area is considered, for example if localised pressure has been identified.

Analysis of this data, together with intelligence held by the Family Information Service and Learning Improvement colleagues, enables the Sufficiency and Participation team to identify areas where there may be an unmet demand or a surplus of childcare places. The team works collaboratively with local childcare providers to find feasible solutions of how best to address



any identified gaps in provision or surplus places, whilst striving to ensure that a high level of quality and flexibility exists for families in Leeds. More recently this has developed into supporting settings manage vacancies due to the decline in the numbers of children in some parts of the city.

## **1.3 Free Early Education Entitlement (FEEE)**

#### 1.3.1 Two-year-old free early education entitlement

Some two-year-old children are eligible for FEEE; eligibility for funding is based on the national criteria. In Leeds all eligible two-year-olds can access a free early education place from the term after their second birthday. Each eligible child is entitled to up to 570 hours per year of free early education from the term after their second birthday for a maximum of three terms. Leeds Family Information Service has rolled out the Golden Ticket Scheme for those children eligible for 2-Year-old FEEE. Parents will receive confirmation of eligibility and are encouraged to take the ticket to a provider of their choice.

#### **1.3.2** Three- and four-year-old free early education entitlement

All three- and four-year-olds and eligible two-year-olds are entitled to 570 hours free early education a year, delivered as a minimum as 15 hours a week over 38 weeks (school term time) but can be taken as a stretched offer with fewer hours a week over more weeks in a year. Since September 2017 eligible three- and four-year-olds have been entitled to an additional 570 hours free childcare, taking the entitlement for some children to 1,140 hours a year. Parents of children accessing a FEEE place can pay for additional hours to meet their childcare needs. This offer is widely available within the sector.



# **2. Early Years education and childcare in Leeds**

## 2.1 Types of childcare available within Leeds

The following types of childcare are available in Leeds:

#### 2.1.1 Full day care

Care for children aged from birth to five, many of which are open all year round, registered and inspected by Ofsted. Full day care includes: -

- Childcare on non-domestic premises including nurseries and pre-schools
- Childcare on domestic premises where four or more practitioners work together to provide care in a home that is not the child's
- Child minders, practitioners who offer care to children in their own homes
- Home child carers/nannies where an individual cares for children in the child's own home
- Children's centres offering childcare in Leeds they are Little Owls settings (24).

### 2.1.2 Other types

- Sessional care, care for children under five and available fewer than eight hours per day. Most settings offer term time provision, and many offer a combination of sessions
- Breakfast club, provision for children before school starts including breakfast and usually offered on site and run by schools. Often, they are funded – Greggs, Magic Breakfast etc – free or low cost and are run for a shorter period than a before school club
- Before school club, a childcare facility provided to a child before school hours typically including breakfast
- After school club, a childcare facility provided to a child after school hours typically including a light tea
- Holiday playscheme, provision for early years and school age children in some or all the school holidays. Typically, most are run by private voluntary and independent providers, however they may also be run directly by schools.
- Nursery class, early education that is part of an infant or primary school
- Crèche provides care for children for under two hours. They are not registered with Ofsted.



## 2.2 Quality of provision

In Leeds, 97% of active early years registered providers received a good or outstanding judgement (overall effectiveness), at their last inspection: -

- 17% were judged as outstanding
- 80% were judged as good
- 92% of funded 2-year-olds are accessing a place in good or outstanding settings.
- 73% of 2-year-olds are benefitting from FEEE funding
- 89% of funded 3- and 4-year-olds are accessing a place in Good or Outstanding settings
- 96% of 3- and 4-year-olds are benefitting from FEEE funding
- 58% of 2-, 3- and 4-year-old children are accessing a place at providers with staff with graduate status
- 61% of children are achieving good levels of development at the end of the Foundation Stage.

## 2.3 Childcare costs

Based on information gathered from providers across Great Britain, the average cost of a part time childcare place (25 hours per week) for a child aged under two in a nursery is £138.70. In comparison, the average Leeds costs are £129.25 for local authority settings and £138 for the Private, Voluntary and Independent (PVI) sector.

The average childminder costs of a part time childcare place (25 hours per week) for a child aged under two across Great Britain is £124.41 per week. The Leeds comparison has found that the average childminder weekly cost across the city is £137.50, which is almost 11% higher than the national average.

## 2.4 Childcare for children with special educational needs and disabilities

## (SEND) in Leeds

Leeds City Council (LCC) is committed to ensuring that children with SEND or disabilities have access to a wide range of high-quality childcare. To support providers to meet the needs of children and young people, LCC provides: -

• Access to Special Educations Needs Coordinator (SENCo) training opportunities



- Funding to enable children to access Early Years settings
- The Leeds Local Offer which provides information on services and provision to families, young people, and children with special educational needs and/or disabilities
- Details of childcare settings that offer places to children and young people in Leeds with SEND can be found on the Leeds Family Information Service website, and parents and carers are encouraged to contact settings to discuss individual specialist provision and support needs for their child.



# **3. Key updates on actions**

## 3.1 Updates on the 2021 - 2022 Childcare Sufficiency Assessment

Action/Priority	Updates
To increase the percentage of take-up of FEEE for eligible 2 Year Old children, by working with childcare providers and schools and investigate effective ways to promote and establish the entitlement, specifically within the low take-up areas. Review the impact of any changes in the take up of 3YO FEEE, specifically 30hrs entitlement, linked to employment changes and patterns of working, post pandemic.	The number of families taking up the 30 hrs offer has increased by 3.3% in the last year. This is reflective of employment levels pre pandemic.
Develop a city-wide survey for parents and carers to help the authority better understand the experience of families with regards to childcare.	An online survey is due to be made available in the summer and the results will be reported in the next update in 2024.
Conduct an audit of before and after school care to ensure sufficient provision available and to understand any impact the pandemic has had on this provision. We regularly signpost to other teams, services, or departments to ensure our settings are sustainable.
Investigate the potential to access funding to provide a business support role for providers needing financial advice in the future.	Providers are supported with the offer of networking (provider meetings) sharing training opportunities and in some cases, settings mentoring each other to address financial issues.
Continue to hold virtual meetings with providers on a termly basis to keep up to date with issues and share information.	Childcare provider meetings continue to be held termly and are represented well. These are proving to be a useful platform for both providers and local authority teams to share and gather information and talk through any key issues that arise.



## **3.2** Actions and priorities for 2023-2024

- Using NHS birth data, birthday cards will be sent to the home address of children about to become 3 detailing the eligibility criteria for 15 or 30 hours of free early education entitlement. This will promote Leeds Family Information Service and links to Little Owls settings. This is a trial and will be rolled out in the 4 childcare planning areas with the lowest take-up of FEEE. The aim is to increase awareness and improve take-up.
- A parent/carers survey will be developed to allow the local authority to better understand parents/carers childcare experience which will help to inform our planning. The online survey will be circulated on the council website and via social media outlets.
- A childcare provider survey will be developed to allow the local authority to better understand key challenges and information such as costs, occupancy and vacancy rates, their financial stability, and any plans to expand places/provision.
- Continue to support early years providers, where requested, by reviewing their offer and models of delivery and work with providers to look at alternative approaches to aid sustainability.
- Continue to work in partnership across key services as part of the priority to raise awareness and increase the take-up of eligible 2-year-old children with a focus on the areas of low take up.
- Continue to work with partners as part of the Nesta Programme Board, where Leeds, along with York and Stockport were chosen to be a local programme. The board focus is on literacy and numeracy, speech language and communication, home learning and research into attendance.

## Appendix D – Childcare Planning Area Summaries

This Appendix provides an assessment of the childcare available in each of the 42 individual Childcare Planning Areas across Leeds.

The following notes apply to all Childcare Planning Areas: -

- Comments for 3- and 4-year-olds are based on data and information available in the summer term 2022 (unless otherwise stated).
- The cross-sector mix statement describes the variety of early education and childcare choices on offer for parents in the planning area. An area that has representation of school-based provision, pre-school, childminders, full day care and Children's Centres would be described as having a good cross-sector mix.
- In addition to comments about the types of providers who deliver before/after school and school holiday provision, some schools may also offer some additional sessions and services outside of core school hours.
- The birth rate, number of eligible children, number of registered places, number of claims for FEEE and any other relevant factors are regularly monitored for each planning area as part of ongoing sufficiency planning work.
- Estimated summer 2023-2025 figures are based on the most recent NHS data of children who will be eligible for FEEE based on where they live.
- Holiday provision is available across the city however supply is led by demand and availability can vary. # **Appendix E – Glossary**

**Universal entitlement** - 15 hours free childcare for three- and four-year-olds. All three- and four-year-old children in England are eligible for 570 hours of free childcare per year from the term after their third birthday. This is usually taken as 15 hours a week for 38 weeks of the year and is known as the "universal entitlement". This entitlement continues until the child starts reception in a maintained school.

**Extended Entitlement** - since September 2017, the Government extended the free childcare entitlement for working parents of three- and four-year-olds to 30 hours per week for 38 weeks of the year (1,140 hours per year). This is known as the "additional or extended entitlement" and gives families, where parents meet the eligibility criteria, an entitlement to 30 hours of free childcare, over 38 weeks (or the equivalent number of hours across more weeks per year), for their 3- and 4-year-olds.

**Early Years (EY)** - children not of statutory school age i.e., under five but not including those who will become five in the academic year.

The Early years framework (EYFS) - sets the standards that all early year's providers must meet to ensure that children learn and develop well, ensures children are kept healthy and safe, ensures that children have the knowledge and skills they need to start school. This statutory framework is for: school leaders, school staff, childcare providers, childminders and out of school providers.

**Demand** - local formation that informs the local authority what parents are requesting.

Availability - relates to the potential number of places.

Supply - registered number of places.

**Delivery/models** - how both the universal and extended entitlement are offered.
